Rules and Restrictions

- Adult supervision is required all the time while the bouncer is in use. Never leave children unattended.
- All bouncers are playing at their own risk.
- Please refer to front of the individual bounce house for specifications for number of people and weight capacity or ask a representative of Leaping Castle.
- Children of approximately the same age and size should play at the same time.
- Keep children away from blower and running around the bounce house.
- The bounce house must be fully inflated before any children are allowed inside and must remain fully inflated until everyone is out.
- Do not wrestle, run, push or climb the walls.
- Remove shoes, eyeglasses, jewelry or any sharp objects before entering the bounce house.
- Exit the unit immediately if the bounce house begins to lose air.
- No pets are to be allowed in the Bounce House at any time.
- No food, beverages, gum or candy in the Bounce House at any time.
- No Confetti or Silly String or any substance like it should not be used in or on the bounce house.
- Do not allow your guests to attempt flips while using the bounce house.
- Do not have the bounce house near fire or high heat
- Do not use bounce house in rain, strong wind or extreme weather.

Cleaning, Damages and Replacement

- Any bounce house returned that requires cleaning over and above regular disinfecting will incur an additional \$50 cleaning charge payable at the time of pickup.
- If the bounce house has incurred minor damage through not following the rules above, the lessee agrees to pay an additional charge of a minimum \$100 or an agreed upon price.
- If any bounce house is damaged through negligence or not following the rules above and is returned in such a condition that it cannot be adequately repaired for safe rental usage, the lessee agrees to pay the full replacement value of the Bounce house equipment in question.

General terms, Liability and Assumption of Risk

1. Statement: There is some risk and danger in Bounce House operations, participants will abide by all the rules as set out in the Rental Agreement so as to minimize their risk and maintain the utmost level of safety. Each person is responsible for their actions and those of their children and guests on and around the bounce house.
2. Assumption of Risk: I hereby assume all of the risks of participating in the bounce house activities and will hold the owner/operator and its employees, agents, officers, trustees, and affiliates harmless from any and all liability.
3. Inspection and Operation of Equipment: The customer acknowledges that he/she has had an opportunity to personally inspect the equipment, found it in good condition that is suitable for their needs. The customer agrees that all rented equipment shall be used and operated only by persons competent in its operation. The customer also agrees to inspect the equipment periodically.
4. General Terms and Conditions: It is hereby agreed that the listed equipment is rented from Leaping Castle by the customer for the customer's own use and the said equipment will not be loaned, sublet, mortgaged or any other manner disposed by the customer. The customer agrees to be liable for any loss of said equipment by fire, theft or any other cause. Once the equipment has been accepted, either verbally or by signature, Leaping Castle would not be responsible for inclement weather and/or any other conditions which may cause the delay or cancellation of an event.
5. Location: The equipment shall be at the address specified by the customer on the rental agreement and the customer grants Leaping Castle the right to enter the property.
6. Supervision and Care: The customer agrees to supervise the operation, use and storage of the leased equipment from the time the equipment is put in the customer's possession until the time the leased equipment is recovered from the customer's possession by a representative of Leaping Castle. The customer further agrees to return all the equipment in the same condition in which it was received, normal wear and tear excepted.
7. My participation in these activities and my signing of this waiver are completely voluntary.

BY SIGNING THIS CONTRACT, THE LESSEE AGREES TO ALL THE PROVISIONS LISTED ABOVE AND AGREES THE BOUNCE HOUSE EQUIPMENT WAS RECEIVED AND INSTALLED IN GOOD WORKING ORDER.
